

## National Standard Revisions Change Log 1984 - 2014

This table briefly summarizes all revisions enacted to the National Standard since its inception. "Revisions Approved" indicates the calendar year in which system changes were enacted and communicated to the field. Each revision allowed time for agencies to modify their systems and begin capturing new data from constituents. "Implementation Year" indicates the calendar year in which most agencies instituted system changes and began reporting data.
