<u>Overview</u>

This report provides a statistical profile of the Washington State Arts Commission's (WSAC's) recent and historical grant investments. The report includes information and trends for total grant activity and per capita grant dollars for each county in Washington with data representing fiscal years 1998, 2003, 2009, 2010, and 2011. The report also presents maps showing the dispersion of grants throughout the state for multiple grant types in FY2009-2011.

Background and Purpose

In fall of 2011, WSAC asked the National Assembly of State Arts Agencies (NASAA) to provide an analysis and report of WSAC's grantmaking activity over five fiscal years. Although NASAA annually collects reports summarizing grantmaking activity from all state arts agencies that receive federal money from the National Endowment for the Arts (NEA), this report represents the first time that the data have been reviewed and analyzed to help determine otherwise undetected trends in WSAC's grantmaking practices.

The results of this report will be used to help point the way to possible markers of success, as well as future directions for WSAC's grantmaking programs.

Methodology

The grantmaking data used in this report are drawn from the Final Descriptive Reports (FDRs) that WSAC submits annually to the National Endowment for the Arts (NEA) and the National Assembly of State Arts Agencies. FDRs use a uniform set of terms and definitions to facilitate comparisons between states. All records are required by the NEA to reflect the locations of award transactions, which may differ from the location of ultimate project activities. In addition to FDR data, statistics in this report have been refined by using data from WSAC program reports. The Executive Director selected the years to be studied.

This report focuses on WSAC programs for Arts in Education, Community Arts Development (discontinued after FY2009), Community Project Funds (discontinued after FY2009), Folk Arts, Grants to Organizations, and State Poet Laureate program. General agency and Art in Public Places funds are excluded from this report. Final data are not yet available for FY2011; therefore, grantmaking figures for FY2011 are based on the most current interim data available September 2011. In conjunction with WSAC staff, NASAA researchers compared multiple reports and analyzed grant program expenditures to determine that FY2011 figures represent more than 90% of total grant dollars spent, thus meriting inclusion within this analysis.

Limitations

While much useful information can be gleaned from data analysis of WSAC's grantmaking programs over several years, the limitations of the data inputs must also be recognized. Key among these are the following:

• Data were analyzed based on the funding address of the recipient, not on the address where the actual event would take place.

 WSAC sponsors several other programs that do not give grants but are nonetheless effective in community outreach and engagement in the arts. Counties that did not receive grants in a particular year could very likely have benefitted from other WSAC programs, such as the Art in Public Places program.

<u>Summary</u>

In observing WSAC grantmaking in fiscal years 1998, 2003, 2009, 2010, and 2011, we found that the FDR data indicate a wide dispersion of funds across the state of Washington. Viewed collectively over the five fiscal years analyzed, WSAC grants were shown to have reached all but five counties in the state (Adams, Columbia, Garfield, Lincoln, Wahkiakum). While King County received the most total grant dollars in each year, Jefferson County consistently reported the largest per capita grant dollars received (\$2.59 for FY2011). High per capita grant dollars received were also reported in Ferry and San Juan counties, at \$2.03 and \$1.24, respectively, for FY2011. The past three years have shown a consistent decline in total grants awarded and dollars spent on grant programs.

The amount of grant dollars available in any given year depends on WSAC's total funding and appropriations. At \$990,300 in FY2011, WSAC grants are nearly half a million dollars below FY2010 funding levels and nearly \$1.2 million below FY2003 funding levels. While funding has decreased, the number of counties funded has remained consistent. In FY2011, WSAC grants reached 26 of 39 counties and in FY1998, 25 counties received funds.

Significant findings:

- In FY2011, WSAC received 249 grant applications, down from 329 applications in FY2010 and 299 applications in FY2009.
- In FY2011, WSAC awarded more than \$990,300 to organizations, down from \$1,403,777 in FY2010 and \$1,917,095 in FY2009.
- In FY2011, WSAC grants reached 26 counties and 63 cities across the state.
- In FY2011, counties with the highest per capita grant dollars received include Ferry, Jefferson and San Juan.
- In FY2011, 49% of total grant dollars went to operating support, and 39% went to arts education.

Maps of Statewide Grantmaking

Introduction

The maps that follow show the distribution of WSAC grants throughout the state. The first nine maps show the reach of total WSAC grants and subsets of Arts in Education grants, Operating Support grants and Project Support grants from FY 2009 through FY 2011. The remaining five maps show the per capita value of total WSAC grants by county from fiscal years 1998, 2003, 2009, 2010, and 2011.

Maps of Total Grants by County, Fiscal Years 2009, 2010, and 2011

Maps of total grants represent all WSAC grantmaking activities in the fiscal years indicated. Arts in Education, Community Arts, Folk Arts, and Grants to Organizations are represented. The maps are similar to one another for each fiscal year, though the total number of grants reported in each year dropped from 276 in FY2009 to 194 in FY2011 (based on the FY 2011 interim report). Maps show a clustering of activities in the Seattle region, with the dispersion of grants across the state being similar in each year.

Maps of Arts in Education Program Grants by County, Fiscal Years 2009, 2010, and 2011

Arts in Education grants support the arts as an essential part of K-12 education through local partnerships, research, training, and grants. These grants include the programs Community Consortium, one Cooperative Partnership, and First Step Grants. Out of the three years studied, the number of Arts in Education grants reached a high point in FY2009, at 32 total grants, and declined in 2011 to 29 total grants.

Maps of Operating and Project Support Grants, Fiscal Years 2009, 2010, and 2011

Operating Support grants support established arts organizations and institutions providing professional artistic events, programs or services to individuals, communities, artists, or arts organizations in Washington. They include the programs Cooperative Partnerships, Large Arts Institutions and institutional support, and Midsize Arts Organizations and organizational support.

Project Support grants are awarded to nonprofit arts organizations to fund specific professional arts events for the benefit of general public audiences. The maps also include Arts Participation Initiative grants.


While the maps representing Operating Support and Project Support grants across the state from FY2009 to FY2011 look similar in each year, an important trend to note is the increasing number of project support grants in relationship to operating support. In 2009, 117 Operating Grants and 94 Project Support grants were awarded. In 2011, 67 Operating Support grants and 87 Project Support grants were awarded.

Maps of Per Capita Grant Dollars Awarded by County, Fiscal Years 1998, 2003, 2009, 2010, and 2011

Per capita grant dollars awarded by county are presented in a series of five maps, one for each year studied. The most noticeable change between years occurs between FY1998 and FY2003. In this time period, per capita grant funding for the state of Washington increased from \$0.26 to \$0.36. The contrast of the FY2011 per capita map and the FY1998 per capita map illustrates the higher funding levels per county throughout the state when more grant dollars were available to WSAC. From FY2009 through FY2011, the maps show a relatively consistent dispersion of funds on a per capita basis, though grant dollars available decreased in each of these years.


















