

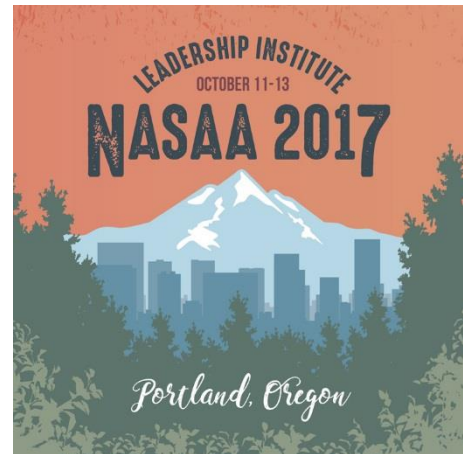

## State Arts Funding Preview for 2018

Learn how state arts agency funding is faring in NASAA's [State Arts Agency Legislative Appropriations Preview, Fiscal Year 2018](#). This report offers insight into the arts funding climate, projected appropriations and per capita rankings for all 56 U.S. states and jurisdictions. The report estimates that aggregate FY2018 state arts appropriations will rise 4.8% over FY2017.

## NASAA Meets with Governors' Advisors

This summer, state economic development advisors and state work-force liaisons met with NASAA and the National Governors Association (NGA) to discover how the arts and culture sector can stimulate economic growth. The NGA convened meetings in Annapolis, Maryland, and Portland, Oregon, to brief these state officials about cultural industry development, arts apprenticeships, entrepreneurship support and work-force readiness programs.

At the meetings, NASAA showcased the [Creative Work Force State Profiles](#), based on data from the Bureau of Economic Analysis and the National Endowment for the Arts, which reveal key employment and compensation statistics for every state. The Maryland State Arts Council and the Oregon Arts Commission shared sample economic and work-force initiatives through the arts.

NASAA is excited to continue our long partnership with the NGA with "Engaging the Arts to Strengthen Economic Development in Rural Communities," coming in 2018.
