



Equity, Inclusion Resources for Council Members

Federal Arts Funding: In Progress

As Congress focuses on the next round of pandemic related relief, NASAA is encouraging provisions beneficial to the arts as well as general aid for states. COVID-19 response means Congress has less time to finalize a federal budget for fiscal year 2021. In late July, the House recommended [\\$170 million in funding](#) for the National Endowment for the Arts, an increase of \$7.5 million that signals strong support for the benefits of the arts for communities across the nation. NASAA is hopeful that, when the Senate turns to FY2021 budgeting, a similar number can be enacted—though a continuing resolution maintaining current levels may be used as an interim measure until after the elections. NASAA will keep our members apprised as actions unfold.

State Arts Funding: Uncertain Forecast

State budget shortfalls caused by the pandemic are causing uncertainty in the forecast for FY2021 arts appropriations. NASAA's annual preview of projected state arts funding provides an initial baseline. Find your state's numbers in our [FY2021 Legislative Appropriations Preview](#), along with per capita rankings for all 56 state and jurisdictional arts agencies. The vast majority of states have indicated their FY2021 appropriations are likely to change, so reach out to NASAA for the latest figures.
