### Connecting with the Incoming Administration and Congress

Following the November elections, NASAA is speaking up for the arts as federal policy directions are being formulated for the year ahead. We're in dialogue with members of President-Elect Joe Biden's transition team, highlighting the importance of the arts and state arts agencies to economic recovery, community resilience, racial equity and other core priorities of the incoming administration. We also are working with Congress to secure an appropriation for the National Endowment for the Arts in fiscal year 2021, and are joining forces with other cultural advocates to urge Congress to include the arts in forthcoming COVID-19 legislation. ### Noteworthy State Arts Legislation

We know that part of the important work you do as a state arts agency council member is to advance policy that's central to the well-being of the arts community in your state. ## Creative Aging Opportunities


