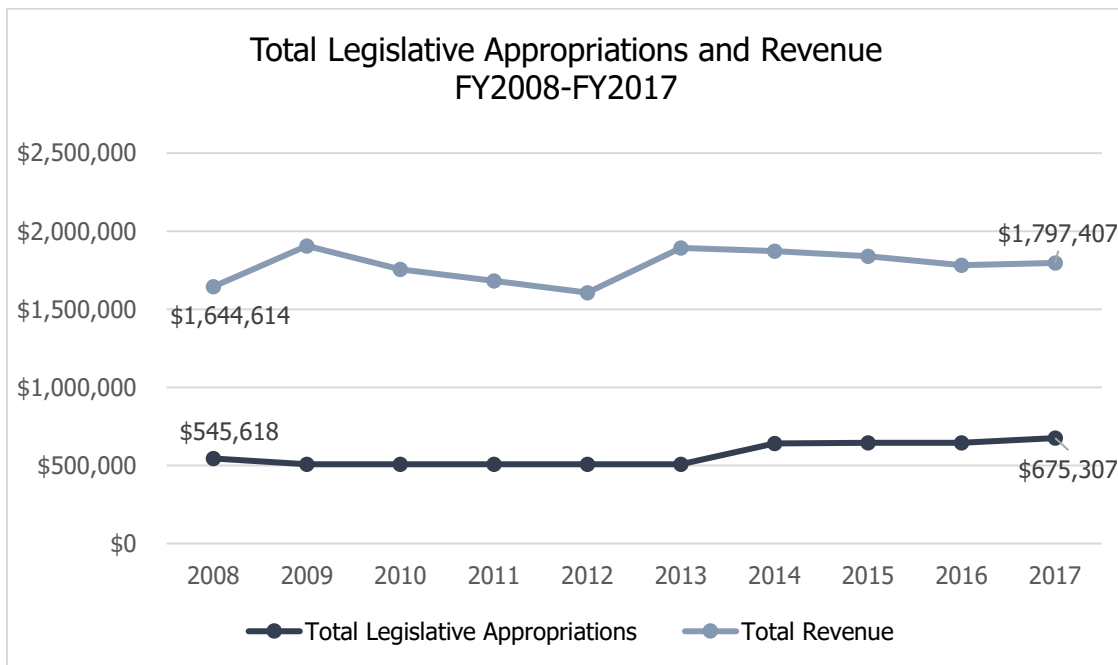

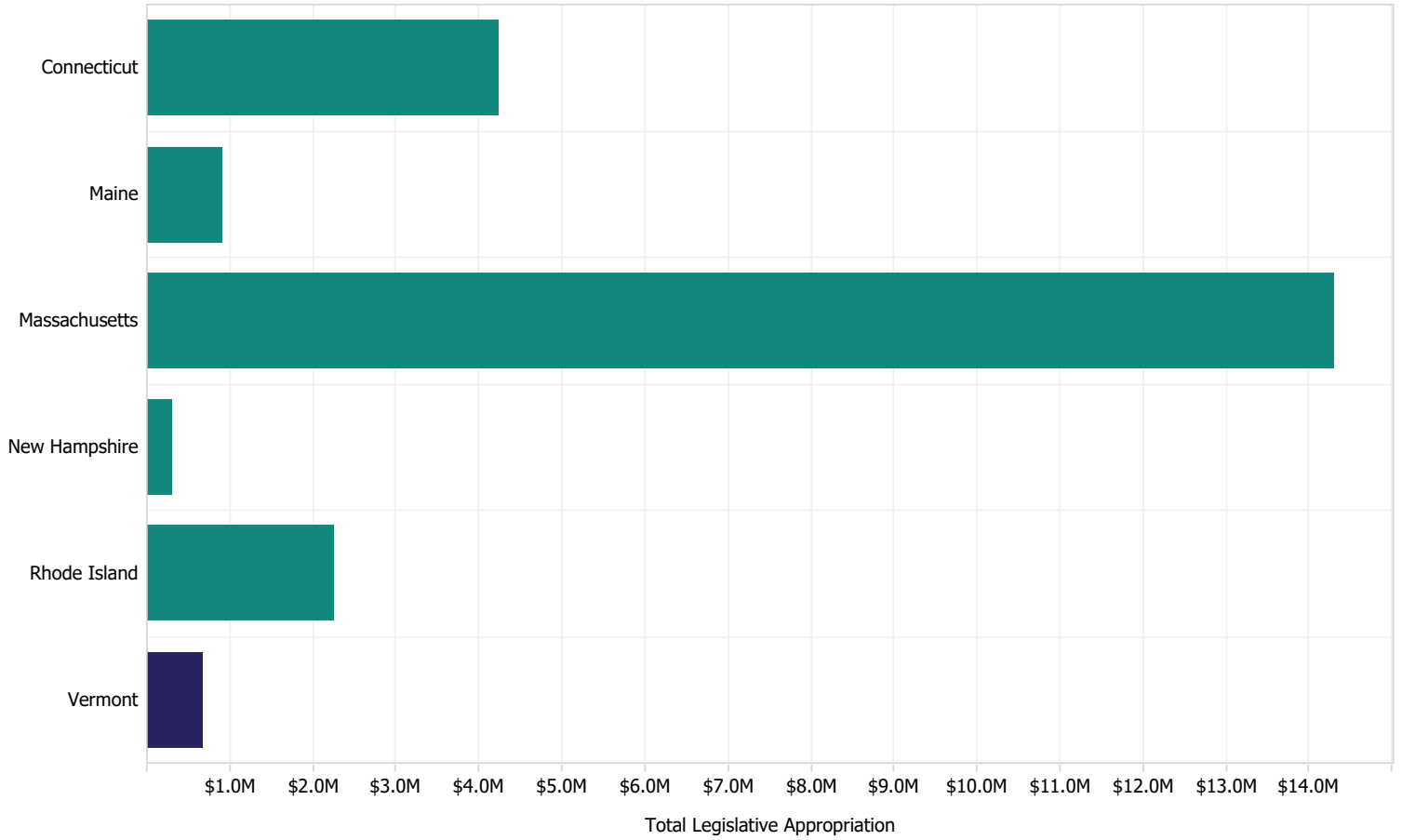

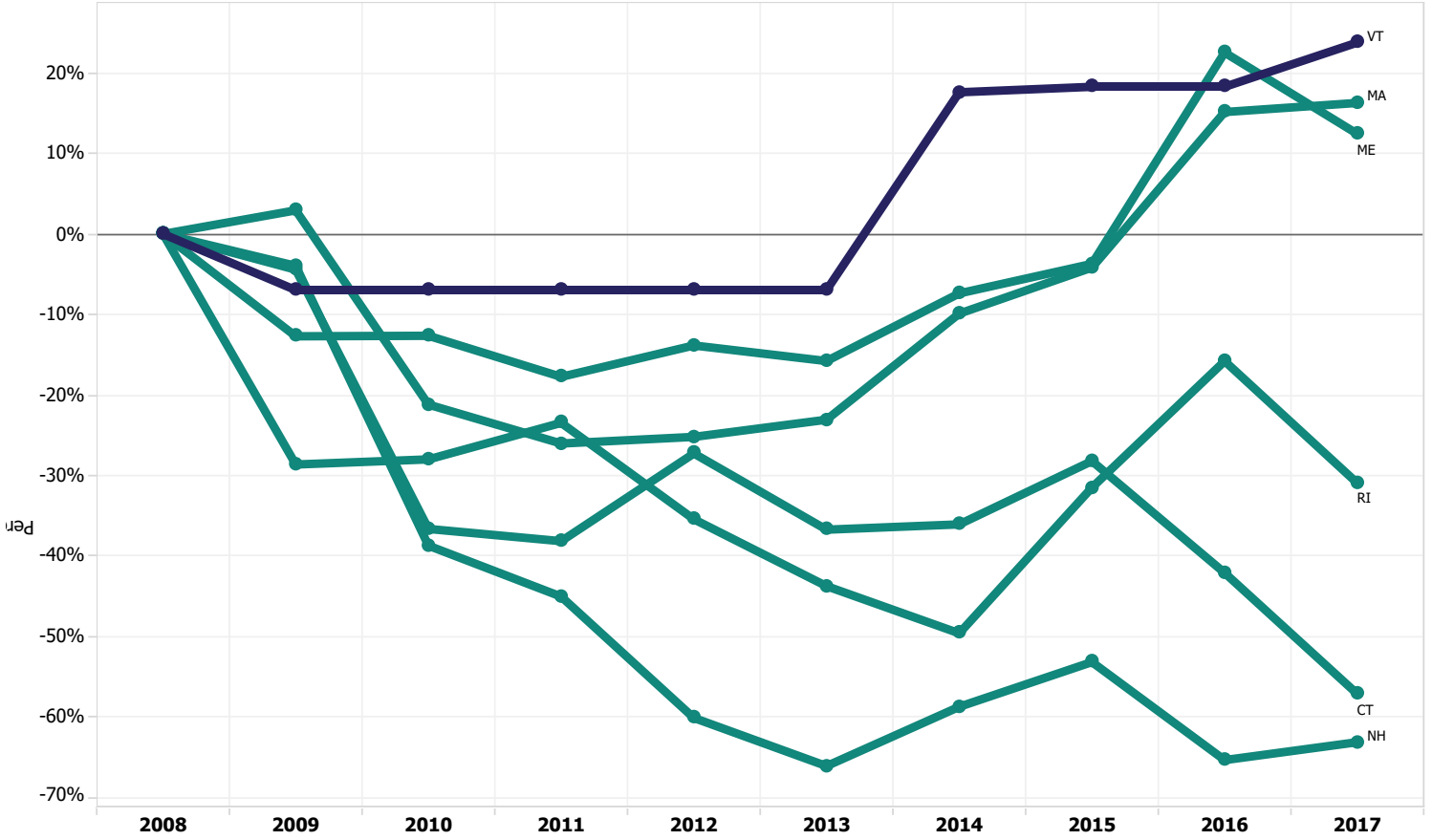
Regional Funding Comparison

Ten-Year Appropriations Percentage Change for New England State Arts Agencies

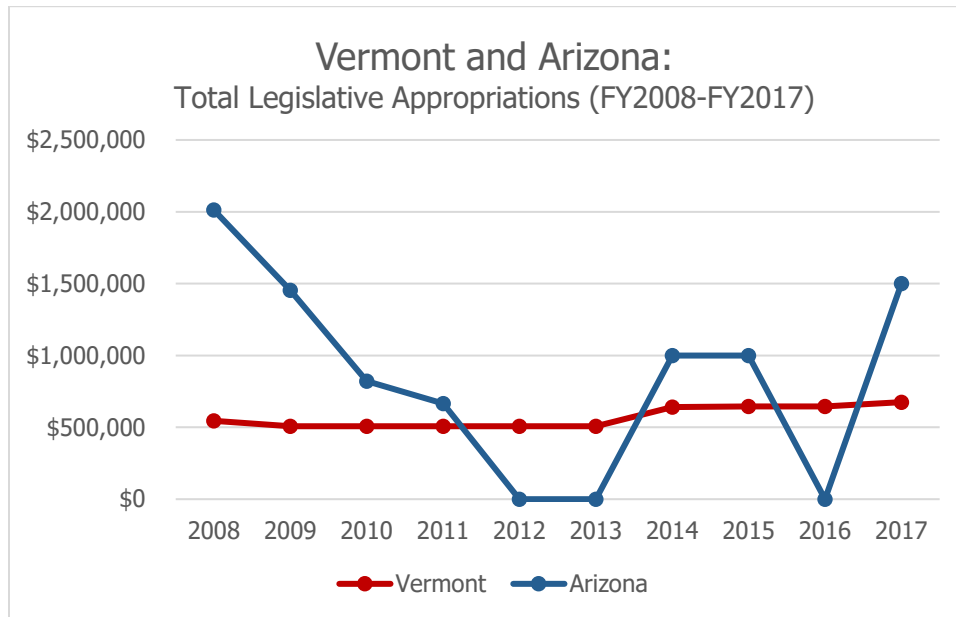
Vermont's legislative appropriations percentage change since FY2008 compared to the other SAAs in your region.
