

## 2022 NASAA Luminary Award for Transformative Executive Leadership Nomination Form

The NASAA Luminary Award for Transformative Executive Leadership honors exceptional leadership by executive directors of the state arts agency (SAA) field.

The award was first established in 1991 as the Gary Young Award by the New England Foundation for the Arts. It honored the memory of a man who made numerous contributions to the early state arts agency movement in the United States. NASAA adopted the award in 1996. In 2022, in recognition of Gary Young's legacy and leadership attributes, the National Leadership Awards Task Force changed the name to the Luminary Award for Transformative Executive Leadership.

### Criteria for Nomination

This award recognizes an executive director who has made a significant contribution to public support for the arts in their state or region. Ideal candidates exhibit exemplary and inspirational leadership, innovative thinking, demonstrated commitment to public support for the arts, and dedication to diverse artistic expression.

### Eligibility Requirements

- All current and past state arts agency (SAA) and regional arts organization (RAO) executive directors are eligible.
- Nominations may be made by any SAA staff or council member or any RAO staff or council member.
- All entries must be received by **June 1, 2022**.

### Nomination Procedure

To nominate an executive director, complete the materials below and submit your packet following the instructions. Nomination packets should include:

- nomination form
- narrative
- nominee's current resume
- letters of support
