

State Arts Budgets Remain Strong in FY2024

As COVID-19 pandemic relief funding wound down, aggregate appropriations to state and jurisdictional arts agencies (SAAs) remained strong. While a couple of states recorded loss of large nonrecurring funds from last year, appropriations increased for the majority of SAAs. Thirty-nine states reported increases for FY2024, with a median rise of 13%. To learn more about SAA funding sources, turn to NASAA's Fiscal Year 2024 State Arts Agency Revenues report. Impactful State Arts Legislation in 2023

NASAA tracked 315 noteworthy arts and culture bills in 2023, 79 of which are highlighted in this report. The Power of Cross-Sector Collaboration

To foster collaborations between the arts and other sectors, NASAA served as a fiscal agent and partner for the groundbreaking Healing, Bridging, Thriving: A Summit on Arts and Culture in Our Communities. Cohosted in January by the National Endowment for the Arts (NEA) and the White House Domestic Policy Council, the summit examined how arts and culture can contribute to community thriving and positive policy outcomes in other fields. Breaux <u>addressed</u> nearly 3,500 in-person and online attendees that included state arts agency leaders as well as federal officials, philanthropists, policymakers, artists, advocates and academics. - Arts + Transportation
- Arts + Infrastructure
