Citizen Councils vs. Nonprofit Boards

Serving on a state arts council is a wonderful arts leadership role! As appointees to a public board, state arts agency council/commission members play important citizen oversight roles and serve as influential arts advocates and ambassadors. While experiences with nonprofit or corporate boards can be good preparation, there are important distinctions to be drawn between nonprofit boards and public boards. Operating within the executive branch of state government offers some unique opportunities to shape policy—and some unique requirements and limitations as well. The Federal-State Arts Partnership

It takes multiple kinds of resources to cultivate a healthy arts and culture sector. In the United States, the arts are sustained by not only private and corporate contributions, but by multiple levels of government support—local, state and federal. The partnership between state arts agencies and the National Endowment for the Arts (NEA) helps to ensure public funding for arts and creativity is spread widely and equitably. In fact, 40% of the NEA's grant funds are allocated to the 56 state and jurisdictional arts agencies and the six regional arts organizations. Clear Evidence: Arts and Creativity Drive Economies

New research commissioned by NASAA shows that the arts are a highly effective economic investment that drives state growth, regardless of how other economic sectors perform. This empirical research, analyzing the period from 2001-2021, provides strong, causal and statistically valid evidence showing that growth in the arts and culture sector positively impacts gross state product and the overall economy. Use Arts and Creativity Drive Economies and Build Resilience to make the case for continued investments in arts, culture and creativity to benefit your state.

There is a causal link between growth in the creative economy and broad economic growth in the United States.

The Latest Data on Your State's Creative Economy

NASAA's annually updated <u>Creative Economy State Profiles</u> dashboard describes the value of arts and cultural production in each state and the nation. These data are published by the <u>U.S. Bureau of Economic Analysis</u> in partnership with the NEA. In 2022, arts and cultural production accounted for:

- over \$1.1 trillion in value added to the U.S. economy
- 4.3% of U.S. gross domestic product
- 5.2 million U.S. jobs
